No refunds for deposits or entry payments will be given at any time [including early and one off season payments] and the purchase of the entry and any payment plan is done so by the competitor on these terms alone. If payments are not made on time or are defaulted upon, Championship status will be revoked, points and achievements declared void and legal action to recover any outstanding amounts including any legal costs will be sought. The Championship has been organised for each competitor for an entire competition year and therefore the terms of payment, the commitment to them and the responsibility to pay on time and in full are unique and legally binding.
